KENYA THREE YEAR EMPOWERMENT PROGRAM - CHILDREN FROM KENYA START THE PROGRAM IN DESPERATE POVERTY AND GRADUATE IN THREE YEARS TO SUPPORT THEMSELVES AND THEIR SIBLINGS. THE PROGRAM HAS A SUCCESS RATE SUCH THAT 95% OF PROGRAM GRADUATES NO LONGER NEED CHARITY AND ARE SUSTAINABLY SELF SUFFICIENT.
